HOW OPPOSITION PARTIES FIGHT AGAINST FLAWED ELECTIONS

Opposition parties in most of the world's newest and least established democracies enter elections knowing that they have little chance of winning. Over half of elections in sub-Saharan Africa, Asia and post-communist Europe saw significant irregularities between 2012 and 2016.

Worse still, few of these elections have seen decisive interventions by either the international community or the judiciary to protect democratic principles. So it shouldn't come as a surprise that more opposition parties are attempting to shift the battleground to the court of public opinion to increase the pressure of judges and international donors.


BOOK OF THE MONTH

2020 GHANA ELECTIONS SIX THINGS TO WATCH



Ghana goes to the polls to elect a President and Members of Parliament in December 2020. It will be the country's eighth successive general election since the resumption of multiparty democracy in 1992. So how are things shaping up ahead of the polls? THINGS TO LOOK OUT FOR ...

Malawi. President Peter Mutharika will ome under great pressure to assent to legislation to reform the electoral commission and pave the way for "fresh" elections on May 19 – but will he?

Ethiopia. Is supposed to be having legislative and regional elections in May, but preparations do not seem to have reached a stage where high quality polls will be possible in this timeframe – so will the elections be postponed?

Africa. There have already been a confirmed case of Coronavirus in Lagos, so the question is now where the virus will spread and how effectively will governments respond – will it be possible to hold elections in Malawi and Ethiopia if there is an outbreak in these countries?
